New Jersey Hospital Opens Chiropractic Department

In October, New Jersey's Montclair Community Hospital announced the opening of a new department of chiropractic medicine, becoming the first hospital in the state to perform manipulation under anesthesia (MUA).

Anthony Oropello, MD, president of the hospital's board of trustees, appointed Albert Cattafi, DC, DSSP, as director of the new department. "We're pleased to join the expanding number of doctors and chiropractors across the nation who work jointly to maximize the quality of health for their patients," said Dr. Oropello.

In addition to his new duties at Montclair, Dr. Cattafi is also chief of chiropractic medicine at the Meadowlands Hospital Medical Center and past president of the New Jersey Chiropractic Society. Two other chiropractors from the surrounding area, Dr. Alfred Davis of Montclair, and Dr. Joseph Salamone of Fairfield, will assist in establishing the department. NWCC Asks the Students
