Participating Facilities in NHSC Loan Repayment Program Announced

In February 2005, the *Federal Register* published details of the National Health Service Corps (NHSC) chiropractic student loan repayment program. The program, part of an appropriations bill signed into law by President Bush on Dec. 8, 2004, will accept up to 40 doctors of chiropractic, and will allocate up to \$2 million in loan repayment contracts to qualified participants.

While the *Federal Register* notice included information on eligibility criteria and ways to apply for entry into the loan repayment program, it did not include contact information for participating institutions. Thanks to the efforts of the American Chiropractic Association, a list of more than 1,000 facilities eligible to hire doctors of chiropractic under the program is now available.

ACA President Named to DoD Chiropractic Advisory Committee

"I am honored to be named to this committee," said Dr. Krippendorf. "As a U.S. Navy veteran and concerned citizen, I want to see America's military have access to the best health care available, including chiropractic care."

The advisory committee provides recommendations to the Secretary of Defense and the U.S. Congress regarding the implementation of chiropractic care for active-duty members of the armed services. Active-duty personnel can currently receive chiropractic care at more than 40 military health facilities nationwide.
