#### Multiple Top Honors for NCMIC

### Remembering Dr. Ruth Sandefur

Dr. Carl Cleveland III, president of Cleveland University – Kansas City, and the entire university community are mourning the loss of Dr. Ruth Sandefur, who passed away on Sept. 15. A 1967 graduate of Cleveland-KC, Dr. Sandefur returned to her alma mater in 1983 as associate professor of diagnostics, then served as associate research director and later, as academic dean. She retired in 2010 as vice president for academic affairs. She remained active with the college after retirement, working on special projects in the Cleveland archives and serving as historical collections associate from 2012 until her passing.

In announcing her death, the university stated: "For more than 50 years, hers was a life dedicated to chiropractic. Her passing is a tremendous loss for the University and the profession."
