Walter Reed Honors Dr. William Morgan

Allstate Decision Reversed

According to multiple legal sources, a New Jersey appeals court has reversed the 2012 judgment that awarded Allstate New Jersey Insurance Company \$3.96 million. Defendants in the case, including chiropractors Dr. Daniel Dahan and J. Scott Neuner, were accused of "creating a dummy medical corporation to misrepresent a chiropractic facility as a physician-owned medical center." The appeals court, however, ruled that the defendants did not intentionally violate state law in establishing the DC-MD business partnership.
